## Invitation for Online Bids for the construction of Helambu Model (Jyambeyang) School

- 1. The **Government of Nepal** and **Helambu Rural Municipality, Office of the Rural Municipal Executive**, has allocated funds towards the cost of construction of Helmabu Model (Jyambeyang) School and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Helmabu Model (Jyambeyang) School (Contract ID No.: HRM/NCB/Works/01/2075-076). Bidding is open to all eligible bidders as per section V of Bidding Documents.
- 2. Helambu Rural Municipality, Office of the Rural Municipal Executive, Helambu, Sindhupalchowk, invites electronic bids from eligible bidders for the construction of Helambu Model (Jyambeyang) School under National Competitive Bidding Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding: Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *NRs 45 Million*. Minimum Work experience of similar size and nature: At least 1 (One) contract related to construction of RCC Frame Structure Two Storey Building within the last ten years, each with a value of at least *NRs. 40 Million*.
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 5. Bidder have the option of submitting their bid electronically only. Submission of Hardcopy bid shall not be entertained. Bidders can down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the non-refundable fee of **NRs. 5000.00** as the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 6. Pre-bid meeting shall be held at Helambu Rural Municipality, Office of Rural Municipal Executive, Helambu, Sindhupalchowk at **12:00 on 30-04-2019**.

Electronic bids must be submitted to the office Helambu Municipality, Office of the Rural Municipal Executive, Helambu, Sindhupalchowk through PPMO website: <a href="http://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before **12:00 on 09-05-2019**. Bids received after this deadline will be rejected. Bidders are requested to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **11:00 on 10-05-2019** at the office of Helambu Municipality, Office of the Rural Municipal Executive, Helambu, Sindhupalchowk. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 1075000.00**, which shall be valid for **30 days** beyond the validity period of the bid.
- 9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- 11. Matters not covered in this tender notice shall be in accordance with public procurement act, 2063 and public procurement regulations, 2064 and other prevailing rules and regulations of Nepal.
