- 4. Sealed Bids must be submitted to the above office of **Helambu Rural Municipality, Kiul, Sindhupalchowk** on or before 12:00 Noon, NST **on December 12, 2017 (2074-08-26)**. Documents received after this deadline shall not be accepted.
- 5. Bids shall be opened in the presence of Bidders' representatives who choose to attend on 13:00 PM, NST on December 12, 2017 (2074-08-26) at the office of Helambu Rural Municipality, Kiul, Sindhupalchowk. Bids must be valid for a period of 90 days (i.e. March 12, 2018) counting from the day of bid opening and must be accompanied by bid security, amounting to a *minimum of NRs. 3,52,500.00*, which shall be *valid for minimum 30 days* beyond the bid validity period (i.e. April 11, 2018).
