Bidding documents may be purchased from the above office of **Helambu Rural Municipality, Kiul, Sindhupalchowk** by eligible Bidders on and before **December 11, 2017 (2074-08-25)** on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. 3000.00. If so requested, the Bidding Documents can also be sent by post/courier services. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the account as specified below and the scanned copy (.pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Sealed Bids must be submitted to the above office of **Helambu Rural Municipality, Kiul, Sindhupalchowk** on or before 12:00 Noon, NST **on December 12, 2017 (2074-08-26)**. Documents received after this deadline shall not be accepted.
5. Bids shall be opened in the presence of Bidders' representatives who choose to attend on **13:00 PM, NST on December 12, 2017 (2074-08-26)** at the office of **Helambu Rural Municipality, Kiul, Sindhupalchowk**. Bids must be valid for a period of **90 days (i.e. March 12, 2018)** counting from the day of bid opening and must be accompanied by bid security, amounting to a *minimum of NRs. 3,52,500.00*, which shall be *valid for minimum 30 days* beyond the bid validity period (**i.e. April 11, 2018**).
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
